1278.04 AREA FOR SLEEPING PURPOSES.

Every room occupied for sleeping purposes by one occupant shall contain at least seventy square feet of floor area. Every room occupied for sleeping purposes by more than one person shall contain at least fifty square feet of floor area for each occupant thereof.

1278.05 WATER CLOSET ACCESSIBILITY.

Every bedroom shall have access to at least one water closet and one lavatory without passing through another bedroom.

1278.06 OVERCROWDING.

Dwelling units shall not be occupied by more occupants than are permitted by the minimum occupancy area requirements in the following Table.

MINIMUM OCCUPANCY AREA REQUIREMENTS IN SQUARE FEET

<u>Space</u>	<u>1-2 Occupants</u>	<u>3-5 Occupants</u>	<u>6-8 Occupants</u>	<u>9or more Occupants</u>
Living Room	No Requirements	120	150	200
Dining Area	No Requirements	80	100	150
Kitchen	50	50	60	100
Bedrooms	Shall comply with Section 1278.04			

1278.07 COMBINED SPACES.

Combined living room and dining room spaces shall comply with the requirements of Section 1278.06 if the total area is equal to that required for separate rooms and if the space is located so as to function as a combination living room and dining room.

1278.08 PROHIBITED SLEEPING AREAS.

Kitchens, uninhabitable spaces, and interior public areas shall not be occupied for sleeping purposes.
