The request of Petitioner Terrence Marshall for a Variation to locate a funeral home use in a building located in the A-1 Single-Family Residential Zoning District, at the address commonly known as 6714-20 W. 16th Street, Berwyn, Illinois, and legally described as follows:

The Public Hearing may be continued from time to time without further notice, except as otherwise required under the Illinois Open Meetings Act.
